Notice of Revision of Financial Results Forecast

Roland Corporation (the “Company”), upon consideration of recent performance trends, hereby announces the revision of its forecast of consolidated financial results announced on February 8, 2013, as detailed below.

1. Revision of Forecast Values of Consolidated Financial Results for Full Year (From April 1, 2012 to March 31, 2013)

2. Reasons for Revision

Although net sales are mostly in line with the previous forecast, operating income and ordinary income are expected to exceed the previous forecast due to a reduction in expenses. Meanwhile, net income is expected to be almost the same as the previous forecast mainly due to posting of an impairment loss associated with noncurrent assets.
